## WHAT IS INCLUDED IN YOUR TRIP?

- The yacht, transit log, fuel, dinghy with outboard engine, damage and liability insurance, bed linen, and final cleaning
- Food onboard: 7 Breakfasts, 7 Lunches, 3 Dinners, Snacks, Water, Tea & Coffee. Also included are 3 bottles of wine per dinner onboard
- Skipper and First Mate
- Arrival and Departure marina fees
- Marine friendly products for use onboard: shampoo, conditioner, soap

## WHAT IS NOT INCLUDED IN YOUR TRIP?

- Additional Marina fees. Many nights we stay at anchorages, which are mostly free. We recommend at least one marina stop mid-week for resupply. We might also decide to seek shelter in a marina in case of adverse weather.
- Alcohol (besides wine with dinner)
- Meals/Snacks/Drinks ashore
- Transportation to and from the marina. However, we can help you to arrange this.
- Personal travel insurance. We **strongly recommend** having personal travel insurance for your trip, especially during the current World crisis.
- Tourist Tax if applicable (usually €1-2 per person per day)

## ARRIVAL DETAILS

Please arrive at the above marina at 6pm on the arrival date. This is to ensure that we have ample time to prepare the boat for your adventure. If by chance the boat is ready earlier than that time, we will contact your designated party leader by phone. We eat out on arrival night as we find this to be an enjoyable beginning to our trip to experience local cuisine and get to know each other. If time allows, we may do a partial safety briefing on arrival night, otherwise this will take place after breakfast the following morning. Then we slip the lines and set sail for the sea of adventure.

## DEPARTURE DETAILS

We typically arrive back the evening before the departure date and dine out this evening too. If the boat charter conditions favour it, there may be flexibility about this. The boat must be disembarked by 9am on departure date.

## FOOD ONBOARD

We kindly ask that you fill in the following form (which will be sent in a separate e-mail) to help us provision the boat for any allergies and/or intolerances, as well as letting us know your preferences in order to minimise waste onboard.

We made the decision this year to have **4 dinners ashore** as the majority of our previous clients wanted to experience more of the local cuisine. It may arise that your group may want to take lunch ashore too on occasion if we happen to dock in a gorgeous Italian town for the afternoon. However, there will always be enough food onboard for lunches.

If you have sailed with us before, you will know that our previous sails were fully catered by us. We have come to realise that a big part of what we love about sailing is the team work, which is why we are encouraging more of a family-style system this time around.

### How will this work?

- Breakfasts will always be buffet style set up by us with plenty of choice according to your requests in the form provided above.
- There are 10 catered meals onboard - 7 lunches and 3 dinners. There will be an additional 4<sup>th</sup> dinner ready in case we cannot get ashore one of the nights.
- Teamwork makes the dreamwork (especially on a boat 😊 ) and we will happily accept help with preparation of our family style dinners.

## DRUGS & ALCOHOL POLICY

Drugs of any kind are strictly forbidden on Wander the Waves sails. If you are found to be in possession of drugs Wander the Waves has permission to remove you from the sail immediately without refund.

One of our favourite things about Italy is the incredible wine it has to offer, and we are excited to sip with you while at anchor or in ports.

Drinking responsibly: If at any point during the sail a crew member is under the influence of alcohol and behaving in a way that would put the boat/crew at risk, the *Skipper* has the authority to remove this client from the sail immediately without refund.

## PACKING LIST

We recommend that you bring a backpacking/duffle style bag as **suitcases** are challenging to store onboard.

Some things we recommend packing:

- Thermals. Handy for night sailing or if it's particularly windy, even in warmer climates.
- Swimming suit
- Warm socks
- Sun hat
- Scarf (for sun protection)
- Towel
- Headlamp/flashlight, ideally with red light option
- Waterproofs
- Snorkelling gear
- **Ear plugs**
- Non-marking shoes
- Sunglasses
- Book
- Passport
- Currency
- Marine-friendly sunscreen
- Marine-friendly products if going down the drains of the boat (we will provide shampoo, conditioner, soap and all cleaning products onboard)
- Bug spray
- Sailing gloves
- **Refillable water bottle**
- Hammock

## MARINE FRIENDLY PRODUCTS

We will provision the boat with toiletries such as shampoo, conditioner and soap to use onboard. We kindly encourage that you do not use any non-marine friendly products in the onboard showers. This is to ensure that our sails are as low-impact as possible on the Ocean we love.

## MEDICAL REQUIREMENTS

Customers must let Wander the Waves know about any medical conditions that would impact their ability to sail. These may include, but are not limited to severe allergies, heart conditions, and physical disabilities. If you have any doubts, please consult your doctor.

If you have a disability, please contact us before booking. We have experience with sailing with disabilities and we will tailor the adventure to your needs.

## COVID-19 - CANCELLATIONS AND PROTOCOL

We understand that Clients may be nervous about travelling in the continued pandemic, which is why Wander the Waves endeavours to adhere to strict protocol to keep everyone safe.

- We require ALL Clients to complete our Covid-19 form. This will be linked to you in your Welcome Email. If for whatever reason you cannot access this or did not receive it, please let us know and we will resend it.
- We require all Client's to either be fully vaccinated, or to take a Covid-19 test no earlier than 48 hours prior to our sail and to do your best to isolate after taking your test before travelling to the boat. This ensures that we can relax together onboard.
- Masks will not be required onboard as it is a tight knit space and social distancing is not possible.
- In the event of a Client needing to cancel due to a positive Covid test, we are sad to say we will not be able to refund you, but we will do our very best to find you a last minute replacement. Again, we strongly recommend taking out travel insurance that covers you for a Covid-19 related cancellation.
- In the event that the *Skipper* has a positive Covid-19 test, the trip will unfortunately need to be postponed unless we are able to find a suitable replacement in a short space of time. In this instance, we will rebook your trip to another date that suits you and your party. Wander the Waves are not liable for any pre-booked transport costs. This will need to be handled by your travel insurer.
- In the event of destination border closures, total cancellation of flights, or restrictions to sailing navigation due to COVID-19, the charter company will rebook the trip to another suitable date.

## IMPROPER CONDUCT POLICY

The skipper has the right to terminate the participation of a client that exhibits a behaviour that is unsafe, aggressive, violent (both physically and verbally), illegal or defiant of the skippers' orders.

The judgment of such behaviour lies solely within the skipper's competence.

Such a client will not receive a refund and will be held responsible for any extra cost and damages that his behaviour incurred.

## DISCLAIMER

All customers must agree to indemnify and hold Wander the Waves, its insurers, affiliates and captains harmless for any injury or death arising from swimming, windsurfing, kayaking, or the use of dinghies, snorkels, masks, scuba equipment, or other equipment, the use of drugs, consumption of alcohol, unauthorized motoring, sailing or motoring in areas designated as hazardous by *Wander the Waves*. *Wander the Waves*, the *Skipper* and *First Mate* are not held accountable for any injury caused by malfunction of a vessel that is not owned and maintained by *Wander the Waves*. In the case of an injury, the passenger remains responsible for negligent acts that may result in harming the passenger and fellow crew.

## FREQUENTLY ASKED QUESTIONS

### **Do I need to have prior sailing experience to go on one of your trips?**

On most of our adventures, prior sailing experience is not required. Willingness to learn is a bonus though and the *Skipper* will be happy to teach you all that you need.

Unless you opt out, you will be welcome to partake in handling and managing the boat, including night watches - and we believe that this is how you enjoy all that the adventure has to offer.

Our *Skipper* is a professional RYA instructor, so if you take a deeper interest, it will not take much persuasion for him to share his knowledge.

### **I'm a little nervous about safety onboard. How do you handle this?**

Safety is our number one priority. Our *Skipper* is a commercially endorsed RYA Yachtmaster Instructor with extensive experience all around Europe and North America. He will never push a questionable situation and will always stay on the safe side.

Our *First Mate* is RYA Day Skipper with experience in various European and Canadian destinations, including delivery passages. All our sailing vessels are equipped with full complement of in-date life-saving equipment including liferaft, life jackets, harnesses, flares, radio and life buoys.

If at any time you have a question regarding safety or any concerns, please speak to the *Skipper* or *First Mate* immediately.

### **What do I do if I get seasick?**

Our experience has it that seasickness is quite uncommon and if it happens, it is very unlikely that you'd be seasick for more than part of a day.

There are good methods to fight a nascent seasickness onboard without the need to resort to medication. However, if you are prone to being sick in a car, or just in case, we recommend you bring some seasickness medication with you (we have good experience with medication containing the natural active agent Scopolamine / Hyoscine). We will also provide mint and/or ginger tea onboard which can also help relieve seasickness.

### **How does payment work?**

Deposit of 50% must be paid at the time of booking. The balance is to be paid 45 days before the start of the sail.

### **What happens if I need to cancel my trip? \*For COVID-19 specific cancellations see above\***

In the event of cancellation by the Client after the deposit has been paid but before balance is paid, the Client will forfeit their deposit. If the Client cancels after the balance has been paid, Wander the Waves will not be able to offer a refund. Wander the Waves will endeavour

to help you find a replacement for your place on the boat, but we cannot guarantee it. We strongly recommend taking out personal travel insurance to cover any unexpected cancellation event and we are happy to comply with travel insurance cases.

### **Do I need travel insurance?**

We highly recommend your own travel, flight, and cancellation insurance.

### **What happens if the weather prevents us from sailing? Will I get a refund?**

We unfortunately cannot guarantee the weather for your adventure, and therefore cannot offer any refunds for adverse weather conditions. In the case of severe weather that prevents sailing, we will endeavour to find entertaining activities on land until we are able to get back out on the water. The decision of whether or not it is safe to sail is solely up to the discretion of the *Skipper* and *First Mate*.

### **I want to go to a particular destination during our sail. Can I request it?**

We always begin our sails by asking each Client about their particular desires for the week ahead. While we endeavour to meet as many of your hopes and dreams as possible, there are limitations. Sailing is a slow-travel experience, and weather plays a big factor in the distance we are able to cover. We cannot guarantee reaching certain destinations requested.

### **I'm worried that my crew might have different ideas on how to spend the week. Some might want to sail all the time, some want to lay on the beach and others wish to explore the towns/villages. How do you navigate accommodating everyone?**

We love having a range of ideas from the crew, and we also believe that getting to experience a bit of what everyone wants will make for a greater experience. However, if there are some very keen sailors who would like more time on the water, while others wish to explore the land, we are happy to accommodate where available. In this case, the *Skipper* can take those out who would like to sail, and return for the other crew later in the day.

### **What will accommodation be like onboard?**

We charter boats that are modern, comfortable cruising sailboats. Accommodation is typically provided in double cabins and a bunk cabin. Most boats have 2 additional beds available in the saloon which on some sails might be used by the skipper and first mate. The saloon also hosts the galley (kitchen), with a cooker, oven and a fridge. There are typically 2-4 heads (toilets with shower) and an additional outdoor shower, all with hot water. As space is limited, everything is compact, but comfortable and functional.

Electricity for charging your devices is available through 12V car sockets. Make sure you bring a suitable charger. Mains power is typically available only in marinas.

The boat is a tight knit space, so we ask Clients to be considerate of others' personal space as well as mindful of noise in the night.

## RELEASE OF LIABILITY, WAIVER OF CLAIMS & ASSUMPTION OF RISK AGREEMENT

By agreeing to this Release, you will waive certain legal rights, including the right to sue or claim compensation following an accident. It is your responsibility to read the Release carefully and in full.

The following waiver of all claims, release from all liability, assumption of all risks and other terms of this agreement are entered into by the Participant (myself or a minor for whom I am the legal guardian) with and for the benefit of Wander the Waves, its directors, officers, employees, volunteers, advisors, officials, business operators, agents, representatives and vessel owners (hereafter referred to as "Wander the Waves").

1. "Activities" includes but is not limited to recreational sailing, sailing instruction, competitive sailing, use of related facilities and equipment, and general participation in programs and services provided to the Participant by Wander the Waves.
2. I am aware that there are inherent and significant risks ("Risks") associated with participation in the Activities. I am aware that those Risks include but are not limited to the potential for serious personal injury, death, property damage or loss and could be caused by any event, accident, negligence or any condition of the vessel or equipment. I understand the Risks may also be relative to my own state of fitness and health (physical, mental and emotional), and to the awareness, care and skill with which I conduct myself while participating in the Activities.

I freely accept and fully assume all responsibility for all Risks and possibilities of personal injury, death, property damage or loss resulting from my participation in Activities. I agree that although Wander the Waves has taken steps to reduce the Risks and increase safety of the Activities, it is not possible for Wander the Waves to make the Activities completely safe. I accept these Risks and agree to the terms of this waiver even if Wander the Waves is found to be negligent or in breach of any duty or care or any obligation to me in my participation in Activities.

In addition to consideration given to Wander the Waves for my participation in Activities, I and my heirs, next of kin, executors, administrators and assigns (collectively my "Legal Representatives"), agree:

- to waive all claims that I have or may have in the future against Wander the Waves;
- to release and forever discharge Wander the Waves from all liability for all personal injury, death, property damage or loss resulting from my participation in Activities due to any cause, including but not limited to negligence (failure to use such care as a reasonably prudent and careful person would use under similar circumstances), breach of any duty imposed by law, breach of contract or mistake or error of judgment of Wander the Waves; and
- to be liable for and to hold harmless and indemnify Wander the Waves from all actions, proceedings, claims, damages, costs, demands including court costs and costs on a solicitor and client basis, and liabilities of whatsoever nature or kind arising out of or in any way connected with my, or my guests' participation in Activities.

I agree that this waiver and all terms contained within are governed by the laws of the United Kingdom of Great Britain. I hereby irrevocably submit to the exclusive jurisdiction of the courts of UK. Any litigation to enforce this waiver must be instituted in the UK where Wander the Waves is registered.

I confirm that I have had sufficient time to read and understand each term in this waiver in its entirety, and have agreed to the terms freely and voluntarily. I understand that this waiver is binding on myself and my Legal Representatives.
